- Deductibles
- Uninsured losses
- Late fees
- Collection costs
- Any other obligations contained in the rental agreement

Nothing in this Authorization transfers liability solely to the Authorized Representative.

4. Authorized Representative Acknowledgement

The Authorized Representative acknowledges that:

- They have authority to act on behalf of the Company.
 - They will comply with all terms of DeHaven Camera Rentals' Rental Agreement.
 - They will use reasonable care in handling all rented equipment.
 - They understand they may be personally responsible for unauthorized acts, fraud, intentional misconduct, or actions outside the scope of this authorization.
